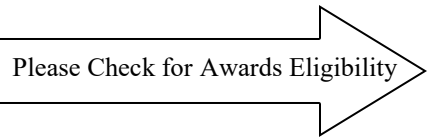

- ◆ **Only USPS Mailed** Entries accepted - **MUST BE POST MARKED OPENING DATE OR AFTER!** No telephone, email, text, personal delivery or pay pal.
- ◆ Current proof of Negative Coggins with Entry.
- ◆ Make Checks Payable to Dunmovin Farm (Return Check Fee \$35.00).
- ◆ Refunds after Opening Date minus \$20 office fee; No Refund after Closing date (except those on the waitlist)
- ◆ No rider substitutions permitted.
- ◆ No class changes after closing date.
- ◆ Formal show apparel optional but not required.
- ◆ Ribbons awarded thru sixth place.
- ◆ Competitors may not cross enter Levels.
- ◆ Classes will run in their entirety before being placed. No classes will be scheduled out of turn.
- ◆ High Score Division Award/Champion at each Level will be the average of 2 tests at the Level (except FEI).
