Amateur Status:

♦ This show is for Amateurs only. **Must be 22 years of age** and have not trained any horse/rider combination for compensation. *Please refer to USEF rules GR101, 1306, and 119.3*

Entries:

All entrants in this competition enter with the agreement that they have read and understand this OFFICIAL PRIZE LIST and agree to follow all the class specifications, requirements, directives, regulations, policies, terms and conditions herein.

- Online entries only. Enter online with <u>Striderpro.com</u> All entries must be complete with full payment and Required Documents (described below) to the Show Secretary, *no exceptions*. All entries must be RECEIVED by the closing date, see note below about late entries and fees. No class changes after closing date. Management reserves the right to return entries that are incomplete or inaccurate. No exhibitor is permitted to show until all fees are paid. Competitors will be subject to USEF Non negotiable funds Rule (GR 1508.1).
- ♦ Required Documents: Coggins within a year of show date. Vaccination Report within six months of show date. This meets the requirements defined in USEF GR 845. Entry Agreements and liability waivers.
- ◆ NO MAIL-IN, TELEPHONE, DROPPED OFF, EMAILED OR FAXED ENTRIES ACCEPTED! ALL ENTRIES MUST BE SUBMITTED ONLINE.
- ◆ Late entries accepted, if scheduling permits, with a \$75 late fee. Entries received after the closing date will NOT be given preference over entries received by the closing date. Scratches may be filled at the regular fee by horses already entered in this competition.
- Entry Confirmation: If you have not been notified of your status two weeks before the show, please confirm entry with the Show Secretary.
- ◆ Refunds: Before closing date full refund less Processing Fee. After closing date NO REFUNDS. "No refunds" includes but is not limited to stabling and overpayments, for any reason including cancellations due to Acts of God, acts of terrorism, inclement weather, and/or other emergencies.
- ◆ All qualified refunds will be made within 30 days of the end of the competition.

Waitlist:

- Waitlist can be entered online at Strider pro.
- Only complete entries will be placed on the waitlist.
- Refunds: Minus processing fee will be returned within 30 days of end of competition

Time Schedule:

- ♦ Official time schedule will be posted in the show office by noon on Friday, August 25th. Unofficial time schedule will be posted on the website and Foxvillage four days before the show.
- Freestyle music test times will be posted in the show office by noon on Friday, August 25th.
- ◆ Freestyle Music: Two Options: 1) MP3 file- send to Dana at dguthrie4@comcast.net 48 hours before show. 2) Bring owner ipad or mobile device that has a headphone jack submitted to secretary at time of registration
- Schooling: Schooling schedules will be posted in the show office and online

General Competition Directives, Regulations, and Policies

- ♦ EVERY CLASS OFFERED HEREIN IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.
- Amateur must warm up horse. Trainers are not allowed to warm up horse.
- ♦ If entering more than one horse in the same division, only one horse can be eligible for Division Championships and must be declared on entry.
- ♦ WORKING OUT OF TRAILERS: Horses must be hand walked down Berkley Rd. behind show grounds to back gate. Entering side gate from Dorset Rd. with horses is prohibited.

♦ Show Photographer

- o **Bethany P Photography** is the official show photographer. All professional photographers not on assignment for Bethany P Photography are not permitted. This policy only applies to professional photographers and spectators with telephoto and detachable lenses.
- This policy does not prevent spectators from using their handheld cellphones and cameras for personal non-commercial use, however, spectators must also abide by the rules and regulations to ensure the safety of all exhibitors and vendors/photographers.
- For the purposes of this policy, a professional photographer is defined as an individual that financially benefits from selling images or photographic services.
- Personal photographers may only photograph from the spectator areas. Do not go along the rail or in gate areas.
- ♦ No soliciting of photographic services allowed on property or via social media.
- Any infraction of this policy will result in expulsion from Devon Fairgrounds properties.
- ♦ US EQUESTRIAN FEDERATION (USEF) rules are in force from the moment show management allows access to the show grounds. This includes conduct, correct saddlery and equipment, and attire.
- ♦ Everyone on show grounds will need to comply with current CDC and local COVID-19 restrictions or requirements, as of the time of the show. Violators will be asked to leave and no refunds will be given.

- "Schooling Show Attire" accepted for performance. Formal attire optional.
- Management reserves the right to split, combine, delete, or add classes dependent on entries.
 Management also reserves the right to add or substitute judges or make any changes required by circumstances.
- Competitors may cross enter Levels but will not be eligible for High Score Division Awards.
- Numbers must be worn on horses at all times when a horse is out of its stall, including when being exercised or ridden.
- ◆ Hazardous Weather/Accident/Acts of God, and Emergency Policy: Management reserves the right to cancel any class(es) due to hazardous weather, Acts of God, accident, or emergency. Every effort will be made to reschedule classes being offered. No refunds for cancellations due to hazardous weather, Acts of God, accidents, or emergencies.
- ♦ All "No Shows" that have not contacted the show office will be considered a scratch for the rest of the show and time slots may be filled.
- ◆ DOGS MUST BE ON LEASHES AT ALL TIMES WHILE ON SHOW GROUNDS OR IN STABLE AREAS. PENALITIES WILL APPLY IN ACCORDANCE WITH USEF GR1301.6
- Levels: Current editions of all FEI/USEF/USDF tests/score sheets will be used.
- Schooling: Schooling schedules will be posted in the show office.
- Area Veterinarians: Will be on call. Emergency numbers will be posted in the Show and Stable offices.
- Farrier: Will be on call.
- ◆ Protective Headgear: DR120.6 states: From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, and those competing in all classes and tests must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds SSTM (American Society for Testing and Materials)/SEI (Safety Equipment institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted.
- ♦ NO SMOKING IN OR AROUND THE BARNS! Smoking in or around the barns is strictly prohibited. This is a zero-tolerance policy, violators may be asked to leave the show grounds.

Arenas:

- Competitions will take place outdoors in 20M X 60M all-weather sand, geo-felt & fiber mix arenas.
- Competition classes will be held in the Wheeler or Dixon Oval show rings. There is no guarantee in which ring classes will be held.

- Warm-up will be all-weather sand, geo felt & fiber mix.
- Lunging: permitted in designated areas only during off-show hours. All lunging must conclude 30 minutes before scheduled classes begin. Lunging and warm-up schedules will be posted and times strictly adhered to.

Stabling:

- ♦ No horses will be admitted to the grounds before noon, Friday August 23, 2024 and must exit the grounds August 24th grounds two hours after the show is over.
- ♦ Permanent 10x10 wooden stalls with doors are on the show grounds. Alteration of stalls or barn structure is strictly prohibited. Careful attention is given to assignment of horse and tack stalls. Do not use stalls not assigned to you or you will be charged. Anyone found changing stalls or using any stall without the prior permission of the Stabling Office will be assessed a \$100 fine per stall. Placing ANYTHING in a stall constitutes the use of a stall. Additional stalls may be rented when you arrive, please see the stable manager. Sharps containers are provided in the barn areas.
- ♦ NO SMOKING IN OR AROUND THE BARNS! Smoking in or around the barns is strictly prohibited. This is a zero-tolerance policy, violators may be asked to leave the show grounds.

General Information:

- ♦ Food: Available on grounds 8/23-24. The food truck will be leaving at noon on the 24th.
- ◆ Parking: Do not arrive after 9 pm Friday, August 23. Trailers or vans will <u>not</u> be allowed to park inside show grounds except for brief loading and unloading. Parking and security will be provided in the surrounding designated parking lots. Trailers or vans will be allowed to park in four designated parking lots directly outside of the show grounds. Be prepared with wheelbarrows or hand trucks to unload on the street or in the parking lot. If your arrival time will be after dark, be aware that lighting is limited in the back barn unloading area.
- ◆ Directions: From Interstate 95 take Rt. 476 to Villanova/St. David exit 13 to Rt. 30 West. The Horse Show grounds are approximately 6 miles on the left. From Pennsylvania Turnpike, take Rt. 476 south exit, and then follow directions above. Please enter 23 Dorset Road, Devon, PA 19333 into your GPS or Mapquest navigator.

- High Score Division Awards: This is presented at each Level.
 - O High score is calculated by the average of two tests ridden at the same level.
 - One of the two tests ridden must be the second test of the level, i.e. Tr. 2, First2 etc.
 - o Must ride two tests of the level which will be averaged for high score
- ♦ Specialty Awards:
 - ❖ Lesley King Award This award is given in the memory of Lesley King and her horse Time Lord (aka Romy) to the competitor with the highest score at the highest Level of the show

B. Activity Risk Classification

RIDER UNDERSTANDS THAT: Horseback riding is a hazardous activity containing numerous inherent, obvious and non-obvious risks that always present themselves in such activity, despite all safety precautions. Related injuries can be severe, resulting in more lasting residual effects than injuries from other activities. Horses are unpredictable and participation in activities in the presence of horses always involves an element of risk. Pursuant to Act 93 of 2005, the Pennsylvania Activity Immunity Act, "You assume the risk of equine activities pursuant to Pennsylvania Law."

C. Nature of Riding Horses

RIDER UNDERSTANDS THAT: No horse is a completely safe horse. Regardless of a horse's training or past experience, a horse may, without warning or any apparent cause, buck, bolt, stumble, rear, kick, run, stop short, fall, bite, make unpredictable movements, spook, jump obstacles, step on a person's foot/feet, push or shove a person, saddles, girths or bridles may loosen or break, all of which may cause Rider to fall or be jolted, resulting in property damage, personal injury, or death. DUNMOVIN DRESSAGE DAYS LLC is not responsible for total or partial acts, occurrences, or elements of nature that can scare a horse or cause it to fall or react in any unsafe way.

D. Rider Responsibility

RIDER UNDERSTANDS THAT: Rider is in primary control of the horse and DUNMOVIN DRESSAGE DAYS LLC is not responsible for Rider's actions or inactions. Rider is responsible for their own safety and that of an unborn child if Rider is pregnant. Pregnant persons should ride horses only under the advice of their physician.

E. Protective Equipment/Headgear Requirement

As a condition of riding any horse in the Adult Amateur Dressage Show, Rider is required by DUNMOVIN DRESSAGE DAYS LLC to wear and utilized all protective clothing and equipment, including long pants, gloves, protective headgear and proper riding shoes with heels, at all times while mounting, riding, and dismounting horses. Rider's headgear must meet or exceed ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carry the SEI tag. The headgear and its harness must be secured, properly fitted and fastened at all times while mounting, riding, and dismounting horses. If Rider is in violation of this requirement at any time, Rider must immediately discontinue riding until such headgear is properly in place.

Closed toe shoes that cover the whole foot are required by all persons on the horse facilities, at all times when working with or around horses. Rider is responsible for ensuring all their spectators and guests abide by this rule if they come within 6 feet of a horse.

F. Property

RIDER AGREES THAT: DUNMOVIN DRESSAGE DAYS LLC is not responsible for lost or stolen personal property of any kind, including saddles, and any other item of value. Rider acknowledges it is their responsibility to secure and insure their personal property.

G. Dunmovin's Use of My Name and Image

I understand that DUNMOVIN DRESSAGE DAYS LLC may take photos or videos of Rider. Rider consents to the use by DUNMOVIN DRESSAGE DAYS LLC of Rider's image, voice, name, and stories (collectively, "Materials"), in DUNMOVIN DRESSAGE DAYS LLC's digital and print promotional, fundraising, educational, and other communications. DUNMOVIN DRESSAGE DAYS LLC may use the Materials without obtaining Rider's approval or paying Rider for such use. In the event that any provision of this Release and Waiver of Liability shall be unenforceable or invalid under any applicable law or be so held by applicable court state decision, such unenforceability or invalidity shall not render this whole Release and Waiver of Liability unenforceable or invalid as a whole.
